I confirm that the financial funds which are transferred to the Bank are received legally and in no way are connected with terrorism financing, sale of drugs, trafficking, avoidance from payment of taxes and other criminal activities.

Disputes and disagreements between the Parties shall be settled by negotiations, otherwise in the order provided by the RA legislation.

We are notified that the disputes and disagreements arisen from the property claim whose amount does not exceed 10mln. AMD or equivalent amount in foreign currency may be settled by the Financial System Mediator\*.

According to agreement signed between the Bank and the Office of the financial system mediator the Bank waives the right to appeal the decisions of the financial system mediator only on the part of those property claims, in which the size thereof doesn't exceed AMD 250.000 (two hundred fifty thousand) or equal foreign currency, and the amount of the transaction doesn't exceed AMD 500.000 (five hundred thousand) or equal foreign currency.

As soon as being accepted by the Bank this application order shall be considered to be executed and due agreement.
